These races typically get less attention but can be every bit as important to us as the highly publicized races.

I also want to encourage you to get involved in some of the campaigns. The candidates always need help and Republican Women have long been an invaluable resource for grassroots campaigning. Some of you might like to choose a day each week to work a few hours in a candidate's campaign office. There is always something to be done - stuffing envelopes, making phone calls, or block walking. If you have never been involved in a campaign, not only will you find that it can be quite interesting and a lot of fun, but it is a tremendous help towards getting your candidate of choice elected.

As a club, we do not endorse one Republican over another in a primary. But, many of you may have a candidate that you as an individual choose to support and work for. Right now we know that there are Republican contested primaries for the governor's race. state railroad commissioner, our State Senate District 7, two State House Districts near our area - districts 133 and 126, as well as judicial races for the TexasSupreme Court, the Court of Criminal Appeals (the highest criminal court in Texas), and two District Court races. The filing deadline is January 2 so there may be some changes in this information by the time you get your newsletter.

Campaign Activities: All of the candidates who will be running for office this year will be in full gear starting in January. They will all need help in making their campaigns successful. Many of our members might be interested in working for the candidates doing things like making yard signs, making phone calls, block walking or working the polls during early voting or on Election Day. Legislative Report: Prior to leaving for their Christmas break, the Senate did pass the "Gulf Opportunity Zone Act of 2005." This Act provides a great deal of release for those affected by Hurricanes Katrina and Rita. Employers affected by Hurricane Rita will get an additional tax credit on a percentage of the wages they pay their employees. It lifted the limits on charitable cash contributions made by corporations, and allowed early withdrawals from retirement plans of those affected by Rita or Wilma without penalty. In addition, it allows for increased expensing deductions for small timber producers in those disaster areas affected by Katrina, Rita and Wilma, and other tax benefits for victims.

Meanwhile in the House, action was taken to increase our border security. On November 17, 2005, the House passed the Border Security and Terrorism Prevention Act of 2005. This bill ends the 'catch and release' policy of other-than Mexican illegal aliens, and will help the Department of Homeland Security to provide enough detention space to hold these undocumented aliens. The Bill also provides for enhanced border patrol operations, physical barriers and state-of the art technology, and streamlining operations within the Department of Homeland Security.

Representative, Michael McCaul, promoted significant portions of this bill.
