# MINUTES

## CY-FAIR REPUBLICAN WOMEN GENERAL MEETING

### November 13, 2007

President Kay Wagborne called the meeting of the Cy-Fair Republican Women (CFRW) to order at 11:05 a.m. at Hearststone Country Club. Mary Moss read a tribute and invocation in honor of Veterans' Day, which was followed by the United States Pledge of Allegiance and the Texas Pledge of Allegiance. Kay welcomed members and guests, including Phil Owens for Charles Bacarisse, Sandy Oliver for Patricia Harless, Jill Fury (member) for Ed Emmett, Emily Klein (member) for John Culberson, Kelli Ray (member) for Gary Elkins and Paul Dwight for Donna Detamore. Several Representatives distributed campaign materials.

Kelli Ray introduced the guest speaker, Tom Moon, Assistant Administrator of Elections for Harris County, who spoke on election laws and party rules. He encouraged the audience to become active in the election process by applying to become Election Clerks and Election Judges. Handouts explained the process to apply for these positions. Four of our members signed up to pursue these positions. He showed the large volume which holds the large number of party rules that are in effect. The Election Day Polling Location Administration Manual was also distributed to the attendees. Mr. Moon explained the steps by which party platforms are determined beginning with the Precinct Convention level and eventually reaching national level. Rules that are on the books now will be enforced for the 2008 election. Any changes of the rules will be effective for the 2010 election. Kay presented Mr. Moon with one of the Peter Barnes' children's books for his signature. The book will be donated to a local library.

The minutes of the September 11, 2007 general meeting were approved as printed in the October newsletter. The High Heels and High Tea event was held in lieu of the October meeting.

Treasurer, Dawn Shull, reported a balance in the treasury of \$8,555.44.

Kay pointed out the new United States flag and the new State of Texas flag and standards which were recently purchased by CFRW.

Mary Moss, Ways and Means Chair, recognized all the members of the High Heels and High Tea committee for their dedication and efforts. She reported that \$8047.85 was raised by the High Heels and High Tea. Cookbooks are still available for sale, as are the Peter Barnes' children's books and club shirts.

Kelli Ray, Membership Chair, introduced two (2) new CFRW members, Leslie Martone and Fran Smith. Revised membership forms will be available at the next general meeting on December 11, 2007.

Newsletter Editor, Rita Parrish, reported that the deadline for the December newsletter is November 30, 2007.

Pam Waldren, Campaign Activities Chair, asked that all attendees of the TFRW Convention report their volunteer hours, including travel time, to her. Rep. Corbin Van Arsdale (District 130) is asking for campaign volunteers for the November 17, 2007 Tomball Holiday Parade and for the December 1, 2007 BlockWalk. Kay presented each of the ten (10) TFRW Convention attendees with a recognition pin.

Legislative Chair, Millie Alford, reported the October newsletter article focused on the problem of family violence. She requested ideas and topics for future articles from the membership.

Awards Chair, Jan Ott, announced that CFRW was recently awarded Second Place for "Caring for America" and the Gold Award (2005-2007) by the NFRW. The TFRW awarded the John Goodwin Tower to CFRW at the recent Convention.

Publicity Chair, Mary Atchison, reported the good exposure CFRW received in the press after the High Heels and High Tea event.

Emily Klein, Historian, asked members to contribute photos for the 2007 scrapbook to be presented to Kay.

Jan Ott, Bylaws Chair, reminded members that the proposed amendments to the CFRW Bylaws were published in the October newsletter. They will be voted on at the December 11, 2007 meeting. The TFRW has approved the current proposed amendments.

#### Old Business:

- The Christmas Party will be held on Friday, November 30, 2007 in the home of Krista and Ray Steele. Cost is \$5 per person. Invitations, map, and reservation form were distributed. Members will find the invitation on the Web site at [www.cfrw.net](http://www.cfrw.net). RSVP deadline is Wed., November 21, 2007.
- The new registration and payment feature on the Web site was enthusiastically received.
- A discussion was held regarding the determination of times of general meetings for 2008, as printed in the November newsletter. A show of hands indicated overwhelming support of daytime meetings. There would, however, be several CFRW events which will be scheduled in the evening. The Executive Board will make a final decision on the matter and an announcement on this issue will be forthcoming.

#### New Business:

- Kelli Ray volunteered to attend the General Council Meeting on Tues., November 20, 2007 in Jan Ott's absence.
- Jan also had Corbin Van Arsdale bumper stickers for anyone who wished to have one.

The meeting was adjourned at 12:30 p.m.

Because of the hard work and active participation of all of the CFRW club members, the club received some very high honors at the recent conventions. At the national convention we were honored to receive both the Caring for America Award and the National Federation of Republican Women's Gold Award. At the recent TFRW convention, the club received the John Goodwin Tower award. All of these awards are for the last two year time frame.

The awards program provides an excellent set of guidelines and goals to help make the club more interesting and productive and ultimately more successful. The Caring for America award recognizes clubs for their involvement and caring within the community. Some of the things included in this award are our dictionary project, contribution of books to libraries including the Peter Barnes' books that we contribute in recognition for our speakers, our support for Operation Interdependence, support for the Western White House Easter Egg Roll and organizing a candidate forum for the community.

The NFRW Achievement Award and the TFRW John Goodwin Tower Award are awarded on the basis of a point system. Points are earned in a variety of categories including club function, membership development, programs, campaign activities, and community relations and service. Some items are mandatory and others are bonus points.

The Gold NFRW Award has four possible levels with Gold being second highest. For the TFRW award we had 815 points out of a possible 870, including 450 required points.

A few of the items included in the awards are maintaining and increasing membership, having issue programs, literacy program participation, sending out a regular informative newsletter, having chairmen of a variety of standing committees, meeting with elected officials, voter registration drives, volunteering on campaigns, supporting our troops, and participating in conventions. By being a member and paying your dues on time every single member participates in the club receiving these awards. Congratulations to each and every CFRW club member!

## WHAT IS NFRW? - Jan Ott



### What is NFRW? TFRW? GHC?

What do all of those letters mean? Cy-Fair Republican Women is part of an organization of approximately 2,600 clubs with 140,000 members affiliated across the nation. NFRW, the National Federation of Republican Women, is now organized in all 50 states and was founded at a conference held at the Palmer House in Chicago, September 23-24, 1938. The organization originally was known as the National Federation of Women's Republican Clubs of America (NFWRC). The name was changed in January 1953, to the National Federation of Republican Women (NFRW). At the time of organization in 1938, clubs with 95,000 members had applied for affiliation. Besides many of the same goals that we have as an individual club, NFRW disseminates information to all state federations and local clubs. NFRW maintains an office in Washington D.C. and you can check out more information on their website at [www.nfrw.org](http://www.nfrw.org).

NFRW has a biennial convention where each club has one voting delegate. These delegates elect the officers and participate in other important decisions pertaining to the organization. The executive committee includes these elected officers, standing committee chairmen and each state president. A portion of your dues goes to the National Federation.

TFRW is the second largest state organization. Seventeen years after the formation of the National Federation of Republican Women, the Texas Federation of Republican Women's Clubs was organized. Individual Republican women's clubs had been in existence in Texas prior to the organization of the National Federation, but it was not until 1955 that clubs existed in 75% of the state's congressional districts (the requirement for federation of a state organization.) In October of 1955, more than 300 delegates met in the White Plaza Hotel in San Antonio for an organizational convention. TFRW lists their purpose as follows: 1. Provide strength and unity for political action within the Republican Party in Texas 2. Actively support Republican candidates 3. Encourage Republican women to run for office 4. Plan local and statewide meetings to broaden and unify the interest and education of its members. 5. Train women to become effective Republican Party workers 6. Inform our members and the electorate through political education 7. Cooperate with the party organization by undertaking special assignments and campaign projects 8. Offer a source of year-round service by Republican Women volunteers 9. Publish TFRW quarterly publication and other political action materials 10. Improve the quality of life in cities across Texas through community service projects. Voting members of the TFRW board include the elected officers, standing committee chairmen, and district directors. Elections are held at the biennial TFRW convention with each club having one delegate for each 10 regular members of their club. TFRW's website is [www.TFRW.org](http://www.TFRW.org). A portion of your club dues also goes to TFRW.

GHC, or Greater Houston Council Federation of Republican Women Pac ([www.ghcfrwpac.org](http://www.ghcfrwpac.org)), is an umbrella organization for 39 Republican Women's Clubs in Southeast Texas - from Matagorda County to Chambers County, from Galveston to Montgomery County. The mission of the Greater Houston Council of Federated Republican Women is to promote political education in order to increase the effectiveness of Republican Women in the cause of good government. In addition, the Council strives to coordinate activities of the various clubs to achieve the maximum efforts of Republican Women throughout the region to elect Republican candidates. Our club has two voting delegates for GHC. The council has general meetings every other month. All members are welcome to attend.

CFRW, being a federated club and participating in all of these levels of the organization, is part of a very powerful and influential part of our government.
