MINUTES



CY-FAIR REPUBLICAN WOMEN GENERAL MEETING April 10, 2007

President Kay Waghorne called the general meeting of the Cy-Fair Republican Women to order at 7:16 p.m. at Prime Time Steak House. Refreshments and a cash bar were available. Dawn Shull gave the invocation followed by the United States Pledge of Allegiance and the Texas Pledge of Allegiance. Kay welcomed members and guests.

Stephanie DeHondt introduced the guest speaker, Harris County Judge Ed Emmett, who recently replaced retired Judge Robert Eckels. Judge Emmett spoke about his role and areas of responsibilities including transportation and mobility, homeland security, health care, criminal justice, economic growth and taxation issues as he presides over Commissioner Courts. The audience appreciated his informative presentation. A Peter Barnes' children's book which he signed will be placed in a school library to honor him as the night's speaker.

The minutes of the March 13, 2007 general meeting were approved as printed.

Dawn Shull, Treasurer, reported a balance of \$5029.92 in the club's treasury. The report was accepted.

Stephanie DeHondt, Program Chair, announced that the speaker for the May 8, 2007 general meeting will be 'Borah Van Dormolen, President of the TFRW, at Hearthstone Country Club at 10:30 a.m. with lunch to follow.

Ways and Means Chair, Mary Moss, reported the High Tea and High Heels fundraiser will be held on Friday, October 12, 2007, at Lindsay Lakes on Mueschke Road off Rt. 290. Donated items are needed for the Blind Auction. The CFRW denim shirts were available tonight for \$30 to those who had placed an order. Bill Lookup

View the status of bills from the 71st Regular Session (1991) to present. Information available includes bill history with actions, amendments, companions, and text of bill.

Reports

View reports representing bills authored, bills sponsored, bills reported to committee, bills by subject, today's legislative activity, general legislature and non-legislature activity.

Vote Information

Beginning with the 79th Regular Session (2005), vote information is accessible by linking from vote actions to the corresponding page in the daily journal.

File Downloads

Download specific documents as an alternative to viewing them through a web browser.

The Senate Research Center also holds a wealth of information. By accessing the website, http://www.senate.state.tx.us/SRC/BA.htm you will learn about a bill analysis in the Senate.

A bill analysis is a summary of a bill written in layman's terms. According to the Senate Rules, in order for a piece of legislation to be heard on the Senate floor, a bill must be accompanied by, among other items, a bill analysis (Senate Rule 7.12(b)(10)).

A bill analysis is composed of three sections: Author's/Sponsor's Statement of Intent; Rulemaking Authority; and Section-by-Section Analysis. If the bill is amended in committee, a fourth section, entitled List of Committee Amendments, will be added to the BA.

- **Author's/Sponsor's Statement of Intent:** This section contains three segments: a statement of current law, the problem which initiated the legislation, and how the bill changes the law to solve the problem.
- **Rulemaking Authority:** This section explains which state-level governmental entity has been given the authority to make rules, on what subject, in which section of bill, and in which section or article of the law it will appear.
- Section-by-Section: This is a summary of proposed changes to each section or article of the law. These are broken up into sections in a bill, and analyzed accordingly. If the bill is substituted in committee, the Section-by-Section Analysis is updated to reflect the changes made by the substitute.
- **List of Committee Amendments:** In this section, amendments made in committee are reproduced in their entirety.
