## **MINUTES**

#### CY-FAIR REPUBLICAN WOMEN GENERAL MEETING November 11, 2008

CFRW President Kay Waghorne called the meeting of the Cy-Fair Republican Women club to order at 11:03 a.m. at Hearthstone Country Club. Kay welcomed members and visitors. In Chaplain Alice McDill's absence, Joy Gregory led the group in prayer followed by the United States Pledge of Allegiance and the pledge to the Texas flag.

Membership Chairman Kelli Ray introduced guests Margaret Montgomery, Carole Harrison, and Kristen Govantes.

Jan Ott, Awards Chairman, introduced guest speaker Joan Neuhaus Schaan, fellow in homeland security and terrorism at the James A. Baker III Institute for Public Policy at Rice University. Her informative and provocative presentation focused on the critical issue of violence and security along the Texas-Mexico border, in Nuevo Laredo particularly, and within the interior of Mexico. Human trafficking, drug trafficking, organized crime/cartels, kidnappings, violence, and corruption within the Mexican judicial system have reached critical proportions. The impact on the economy and human life are a threat to Mexican democracy and are of vital concern to the United States and, especially, to our border states. A question and answer period followed.

Kay thanked all members who have volunteered their time and talents to the recent political campaign.

Secretary Betty Guthrie announced that the minutes of the October 14, 2008 general meeting were published in the November issue of the CFRW Newsletter. Members approved the minutes as published.


