*Judge Bill Moore* has become someone CFRW feel like we can call "our own" since we have gotten an opportunity to get to know and visit with him. At our September meeting, we now have a special chance to have him talk to us about the nine criminal district court benches that are on the November ballot, why voters should be concerned about them, and discuss the background of several of the candidates.

Bill was hired by District Attorney Johnny Holmes in 1988, and has served as a Harris County Assistant District Attorney for the past 20 years. During those 20 years he has tried over 100 jury trials, served as the Deputy Chief of the Misdemeanor Division, and served as a Special Crimes Prosecutor handling hundreds of complex financial fraud and organized crime cases.

As a Chief Prosecutor assigned to the Trial Bureau, he has prosecuted many high profile murder and capital murder cases. Bill has served as the Chief Prosecutor in the 180th District Court, the 351st District Court, and currently serves as the Chief Prosecutor in the 232nd District Court.

In March Bill won a contested Republican Primary Election and April Run-off Election to replace retiring Criminal District Court Judge George Godwin in the 174th District Court, and will be on the ballot in the upcoming November General Election.

All of the judge's races often get much less media attention but these are critical positions for our everyday lives. Invite your friends and neighbors to hear Judge Moore talk about these very important contested places on the ballot.

# **BY-LAWS REVISIONS**





#### **By-Laws Revisions**

Cy-Fair ladies, please look over the suggested changes to our by-laws. The club by-laws must be approved not only by our club, but, also by TFRW. There are some requirements that all Texas Federated clubs must include. The proposed changes are to bring our by-laws into compliance with these requirements plus some clarifications that the by-laws committee recommends. Below are only the portions of the by-laws that include any changes. These will also be presented at the next meeting and will be voted on at the October meeting. As you all know, the complete by-laws are in your club membership book. We ask you to review these changes before the next meeting and if you see anything else that we need to discuss we can do that at the next meeting.

### Article III - Policy

#### Section 1. PAC

 This club shall be a Political Action Committee and registered as such with the Texas Ethics Commission.

 The following 5 items have been renumbered to allow for the insertion of item #1.

 Section 12. Candidate Endorsement:

 This organization, its president, .......(no change)

 Section 23. Working For a Candidate:

 Individual members of this organization, .......(no change)

 Section 34. Endorsement Exemption:

 This article pertains only to contests between Republican candidates for public office. .........(no change)

 Section 45. Controversial Issues:

 This organization and its officers shall not issue statements or pass resolutions .......(no change)

 Section 65. Lobbying

 There shall be no lobbying with Legislators using the name of the Texas Federation ........(no change)

### **Article IV - Membership**

#### Section 1. Eligibility:

Any woman <u>U.S. citizen</u> believing in the philosophy of the Republican Party and intending to support Republican Candidates and believing in the objectives of this organization shall be eligible for membership.

#### Section 2. Classification of Membership:

- a) Active Member: An Active Member is a woman who meets the eligibility .....(no change)
- b) Associate Member: An Associate Member is an active member of another <u>TFRW Club</u> Republican Women's organization who wishes to join this organization as an Associate Member by paying the required annual dues for Associate Members. She cannot hold office, vote or be counted for the purpose of determining the number of delegates to national or state federation meetings or conventions.
- c) Supporting Member: A man person may become a Supporting Member and be listed on our the club roster by paying the required annual dues for Supporting Members. A Supporting Member is *ex officio*, without voice or vote and shall not hold elected or appointed office. Supporting Members shall not be listed on the roster sent to the Texas Federation of Republican Women or National Federation of Republican Women.

#### Section 4. Annual Service Charges:

This organization shall also pay the annual service charges required by the Texas Federation of Republican Women and the National Federation of Republican Women.....

### **Article VII - Nominations and Elections**

#### Section 1. Nominating Committee:

A nominating committee of not less than three and not more than five <u>membersActive Members</u>, at least three of whom shall not be a member of the Executive Board, shall be elected by the membership at the September meeting of every even-numbered year. The Nominating Committee shall elect its chairman from one of its own number and shall report one nominee for each office at the October meeting of every even-numbered year.

\_\_\_\_\_ The President shall preside at all meetings of the organization and the Executive Board. She shall appoint chairmen of all standing and special committees with the approval of the Executive Board, shall appoint a parliamentarian, shall serve *ex officio* as a member of all committees except the Nominating Committee, and shall have general supervision of the work of the organization.

\_\_\_\_\_ The 1<sup>st</sup> Vice President shall perform the duties of the President whenever the President is absent or otherwise unable to serve. She shall serve as **Program Chairman** and perform such other duties as the President or Executive Committee or Board of Directors may designate.

\_\_\_\_\_ The 2nd Vice President shall assume the duties of President in the absence of the President and 1st Vice President. She shall serve as Ways & Means Chairman.

\_\_\_\_\_ The 3<sup>rd</sup> Vice President shall serve as Newsletter Editor and shall be responsible for publication of the newsletter.

\_\_\_\_\_ The Secretary shall keep a factual and unbiased record of the proceedings of all meetings of the organization and the Executive Board, shall prepare the correspondence of the organization, shall have custody of all records pertinent thereto and shall perform such additional duties as may be required of the office.

\_\_\_\_\_ The Treasurer shall receive and is custodian of all funds of the organization and shall pay all bills upon authorization by the President. The Treasurer shall keep an account of all monies received and disbursed and shall give a report at each regular meeting of the organization to the membership. She shall make timely membership submissions and payments to the Texas Federation of Republican Women. She shall ensure that adequate records are kept to satisfy the requirements of the Texas Ethics Commission and Texas election laws, and shall file all reports required by them in a timely fashion. She shall submit her financial records to the internal review committee for an end of the year review no later than January 20.
