#### CY-FAIR REPUBLICAN WOMEN GENERAL MEETING July 14, 2009

# **LEGISLATIVE - Dawn Shull**



Health care reform is ObamaSpeak for health care rationing. It doesn't have to be this way. Look at <u>The Health Care Freedom Plan</u><sup>1</sup> that Senator Jim DeMint has put forth - a reasonable plan that will actually help all families obtain health insurance while not taxing us to death. With the current Democratic congressional stronghold it will not see the light of day because it puts us the people in charge and not the government.

The line that we will be able to keep our current health plan is just one of many <u>broken promises</u><sup>2</sup> with the health care plan now in Congress whose "goal is to reduce everyone's consumption of health care and to ensure that people have the same health-care experience, regardless of ability to pay". Democrats like to tell us we have a <u>right</u> to health care<sup>3</sup>, but isn't a <u>right</u> the freedom to choose our own rather than being forced to accept government dictated terms?

How can proponents claim this plan will not cover <u>illegal aliens</u><sup>4</sup> when the House defeated a Republican amendment written precisely to keep this group from receiving health care subsidized by the government? The current legislation may not overtly include illegal aliens but neither does it "require any state, federal, or local agency to check the immigration status of those who apply for the program." The possibility of fraud is rife.

Congress, as a means to cover a number of uninsured, is considering a proposal to <u>expand medicaid</u><sup>5</sup> in a major way. This counteracts the proposed individual mandate to buy health insurance by removing large numbers of healthy individuals from the general pool, thus reducing the mandate's effectiveness.

Far from the claim that ObamaCare will not "tax" most Americans, the truth is the burden will ultimately fall on all Americans, particularly on lower income Americans. The employer mandate<sup>6</sup> part of the proposed bill will most certainly result in employers eventually passing their costs on to their employees through "lower wages, smaller raises, less frequent promotions, lower starting pay to new employees, and/or wage cuts due to the 'recession.'"

American Thinker writer Randall Hoven supports <u>universal coverage</u><sup>7</sup> but not a national health care or single-payer system. His plan would call for important guidelines including a limit on public health spending based on GDP, medical tort reform and private choices.

Dr. John Dunn has a very interesting perspective on <u>healthcare policy</u>, <u>social justice and thugs</u><sup>8</sup> in which he discusses "the beginning of the death of good American Medicine 35 years ago..." He purports that good, cheap catastrophic health insurance is the way to go for most Americans.

For a dizzying overview of what may be in store for us, you must check out the <u>Organizational Chart of the House Democrats'</u> <u>Health Plan</u><sup>9</sup>. It speaks for itself.

For insight into what President Obama thinks and values in this health care debate, look at two of his key health care advisers. For good reason Betsy McCaughey refers to them as <u>deadly doctors</u><sup>10</sup>. Dr. Ezekiel Emanuel (brother of White House Chief of Staff Rahm Emanuel) says that "communitarianism' should guide decisions on who gets care," and that "<u>medical care should be reserved for the non-disabled</u>, not given to those 'who are irreversibly prevented from being or becoming participating citizens." The good doctor also "<u>explicitly defends discrimination against older patients</u>." Consider that the current bill is to be funded by a \$500 billion-plus cut in Medicare over 10 years and I think you get the picture. Dr. David Blumenthal "<u>recommends slowing medical innovation</u>" and <u>considers the value of timely health care "debatable</u>."

If you have a couple hundred hours to spare, read H.R. 320011 for yourselves.
