# MINUTES

CY-FAIR REPUBLICAN WOMEN GENERAL MEETING

August 11, 2009

Mary Moss, President, called the meeting to order at 7:15 p.m. at the Twin Lakes Community Center at 13209 Sunbright Drive, Houston, Texas. Chaplain, Suzanne Davis, led the invocation and pledges to the American and Texas flags. Mary stated that both candidates had been asked to attend our forum, but Mr. Woodfill was not available.

Rita Parrish, Programs Chairman, introduced Mr. Ed Hubbard who is running for the position of Chairman of the Harris County Republican Party. He spoke for ten minutes on how he thinks we can reinvigorate the Party. He feels that we need a revolution in how we approach the organization of the Republican Party in order to make it more effective. Traditionally, Republicans are in the suburbs. We need to develop urban policies that will help us get the urban vote. We also need to expand our base by reaching out to minorities.

He thinks we should reunite the party through our shared values and principles. He would restructure the party so that information would flow better. He encouraged us to seek out our neighbors and invite them to be a part of the Republican Party in order to expand its growth. Out of the more than 600 Harris County elected positions, Republicans ran for 200. We need to get involved at the grass roots level.

We had a fifteen-minute Q&A session with Mr. Hubbard after his talk. This discussion focused on how we can get more people into the Republican Party.

Rita then introduced State Representative Dwayne Bohac who stated that we need to unify and grow the Party by finding solutions to the problems that affect our citizens. He indicated that Republicans were able to pass the following: A balanced budget that left \$9 million in the bank; a bill that removed taxes from school supplies; a bill that increased the tax base on small businesses from \$300,000 to \$1,000,000; a bill that creates a pathway for the University of Houston to become a Tier I University; and, a bill that prohibits the use of Eminent Domain for private economic development.

Rita Parrish then introduced Mr. Gary Elkins, local State Representative, who indicated that Acorn would be doing the next U.S. census. He fears that there will be a counting of illegal immigrants and duplications made that will diminish the effectiveness of the Republican Party. We need a Republican majority in the Texas State House (we now have 76 Republicans and 74 Democrats) when the district lines are drawn. We must get more Republicans elected in order to get conservative legislation passed. Elkins suggested we need alternative media due to the current media bias toward Obama. He suggested we follow him through Twitter and Facebook.

Rita then introduced State Representative Bill Callegari. He indicated that the past session was not a good one for Republicans. Many of the bills passed by the legislature took away individual freedoms. There was a five-day slow down by the Democrats, which prevented Republican bills from being passed. There were 1400 bills passed and a lot of them were special purpose bills—bills that affect one or so persons. He urged us to be vocal and work to get Republicans elected.

Another Q&A session followed in which the lottery, gambling casinos (both men are against gambling in Texas), and school taxes and funding were discussed. We were told that a property tax law was passed that limits tax appraisal increases to ten percent for each two-year period.

Mary Moss then announced that there would not be a business meeting and reminded us about the High Heels and High Tea event in October and that the newsletter deadline is Monday, August 24, 2009. Mary then adjourned the meeting at 8:42 p.m.

## LEGISLATIVE



The Texas Department of Public Safety announced that new driving laws have been passed which will affect Texas drivers of all ages effective September 1, 2009. This information is especially timely as our children begin a new school year. Here are a few of the bills which were included in HB 2730. For more complete information go to [www.txdps.state.tx.us](http://www.txdps.state.tx.us) from which the following portions are quoted:

### **Seatbelts:**

“HB 537 requires all occupants of a vehicle, no matter their age, to be secured by a safety belt, no matter where they are seated in the vehicle...prohibits a motorcycle operator from carrying a passenger under the age of 5 unless the child is seated in a sidecar attached to the motorcycle.”

“SB 61 amends the existing statute regarding child passenger safety seats. The bill requires that any child younger than 8 years of age be restrained in an approved child passenger safety seat unless the child is at least 4 feet, 9 inches in height...”

### **Driving:**

“HB 55 makes it illegal to use a wireless communication device in a school zone unless the vehicle is stopped or a hands-free device is used...”

“HB 2730 increases the penalties for driving while intoxicated with a child passenger by adding an automatic driver license suspension period for first-time offenders and an increased suspension period for repeat offenders...”

### **Driver license:**

“HB 2730 requires that all applicants under the age of 18 take the driving skills exam to receive a driver license. The law also requires that a provisional driver license (under 18) or instruction permit expire on an individual’s 18<sup>th</sup> birthday, removes the requirement that a provisional driver license or instruction permit be renewed annually and increases the fee for those licenses from \$5 to \$15. It also extends the current phase-two restrictions for holders of a graduated driver license from 6 months to 1 year. These restrictions include limited night driving, prohibited use of wireless communication devices and a limited number of passengers.”

“HB 339 increases the total hours of behind-the-wheel driving instruction a teen receives from 14 to 34 hours after TEA develops criteria for curriculum. (Goes into effect May 1, 2010)”

“SB 328 gives DPS the power to suspend a minor’s driver license if they fail a breath or blood alcohol test while operating a watercraft...”

### **Crime:**

“HB 558 allows minors to be charged with public intoxication.”

## CARING FOR AMERICA - Debbie Brown

A recent e-mail read, “According to the weather reports, it is our understanding that it is 122 degrees in Baghdad, Iraq right now — and the low will be 95 degrees!” Wow! I cannot imagine what our soldiers are going through in Iraq, Afghanistan and many other parts of the world, dressed in thick combat fatigues, body armor, and carrying the heavy weight of equipment in the blistering heat. Our troops need prayers for strength, endurance, and safety in these extreme weather conditions. We are blessed to have one of the finest volunteer military personnel in the world protecting the freedoms we enjoy in the great USA.
