A Minute with Mary

On March 20, County and Senatorial (SD) Conventions were held across Texas. These were the second steps in a process that allows grass roots participation in shaping the Republican Party of Texas. The next step is the State Convention that is to be held in Dallas in June. At this convention delegates will elect the party officers for the next two years and vote on items to be included (or not to be included) in the party's platform.

On that March Saturday, delegates were elected to the State Convention. I am proud to say that CFRW had nine ladies in attendance and all nine were elected to be delegates to the State Convention. Congratulations and thanks to Barbara Buxton, Suzanne Davis, Joy Gregory, Mary Moss, Jan Ott, Rita Parrish, Gail Shubot, Kay Waghorne, and Jude Wiggins for giving of their time to attend. They will be going to Dallas to represent their precincts, Senatorial District, and CFRW.

The tasks before these delegates will be to elect the Party's officers, finalize and confirm the Republican Party of Texas' Platform. At our SD Convention we voted on 61 resolutions to be presented to the State Resolutions Committee. These resolutions came out of all the Precinct Conventions. These resolutions were scrutinized by the SD7 Resolutions Committee. In some cases the resolution was merged with similar resolutions to make up the final list. This list will be sent to the Resolutions Committee at the state level, where they will be added or combined with other resolutions from around the state.

These 61 resolutions were presented in the form of a committee report and concerned diverse topics ranging from abortion, border security, health care reform, immigration, government spending and almost anything else you can imagine in between. Since our party is as diverse as our country, not all of us agreed with each and every one of these resolutions. The convention gave an opportunity to debate some of the resolutions, but due to

MINUTES

CY-FAIR REPUBLICAN WOMEN GENERAL MEETING March 9, 2010

President, Mary Moss, called the meeting to order at 11:02 a.m. at Carrabba's Italian Grill. Emily Klein led us in prayer and pledges to the American flag and the Texas flag. Joy Gregory introduced guests and new members. Rita Parrish then introduced Mr. Kendall Miller from the group Texans for Lawsuit Reform. He gave an overview of legislation past and current that the organization has worked to get implemented by the Texas legislature, and how the organization was able to effectively get tort reform laws passed.

OFFICERS' REPORTS:

Secretary, Doris Jones, indicated the February's minutes were printed in the Newsletter, and they were approved as published.

Treasurer, Barbara Buxton, reported that our balance as of January 31, 2010, was \$11,717.39. Deposits of \$1,443.00 and payments of \$894.01 were made during the month which left us with a balance of \$12,266.38. The balance of the scholarship fund as of February 28, 2010, was \$901.08.

Ways and Means Chair, Millie Alford, was not present; however, Mary indicated that T-shirts were available.

Newsletter Editor, Betty Guthrie, informed us that the Newsletter deadline was Monday, March 22, 2010.

COMMITTEE REPORTS:

Membership Chair, Joy Gregory, indicated we now have 56 active members (new and renewed members), 13 dual, and six associate (men). We have 24 or 25 memberships that have not yet been renewed. Our goal for 2010 is 81 active members. We ended 2009 with 70 active members, and we will have a Membership Drive in May.

Campaign Activities Chair, Lois Barclay, passed around the volunteer hours sheet and said she would be registering voters at Lone Star College on Wednesday between 11:00 a.m. and 1:00 p.m. Anyone who would like to help can speak to her after the meeting.

OLD BUSINESS:

Treasurer, Barbara Buxton, informed us that the Financial Review Committee had reviewed the books of the organization, and they had found them to be in good order.

Dawn Shull, Legislation Chair, gave a report on the Primary Convention and indicated that the run-off election will be held on April 13th, and early voting for the run-off will be held April 5th - 9th.

Mary stated that the Greater Houston Council "Nuts 'N Bolts" workshop was informative, and all of the women who attended had a great time.

Rita reported that the Judges' Forum was a success. Even though we had some very extreme weather the night of the forum, we had a great candidate turnout. The audience was able to track and make notes on the candidates with our handout. Rita thanked the members who helped with the event.

NEW BUSINESS:

After a discussion of the Cy-Fair Women's Expo, Jan Ott moved that we get a booth at the event which will be held on April 21, 2010, at the Houston National Golf Club from 11:00 a.m. to 2:00 p.m. Lois Barclay seconded the motion, and the motion

was passed. Cost of the booth is \$75.00. We will register voters, accept memberships, and sell cookbooks. We hope the booth will give the club more exposure within the community.

Our Membership Drive will be May 11, 2010.

There will be a Tribute to Women at the Dallas Republican State Convention on Friday, June 11, 2010 at 9:00 a.m. The cost is \$59. Mary explained that four women from each club can be honored. Usually it is the club's past and current presidents who are honored by their clubs. These women will be honored at the convention and will get their picture taken with a Republican dignitary. Mary passed out a sign-up sheet for those who wish to attend the event. We can think about whom we wish to nominate and take a vote at the next general meeting.

LEGISLATIVE - Dawn Shull



Were you amazed at the national coverage our State Board of Education received last month? Do you even know who they are? There are 15 members who are elected for four-year terms (usually appearing way down the ballot) and uncompensated¹. Harris County has three board members: District 6 (West) - Terri Leo (R), District 4 (Central) - Lawrence Allen, Jr. (D), and District 7 (East) - David Bradley (R). Usually they do their appointed work in relative obscurity, but when they talk about changing the history textbooks to reflect a more conservative curriculum² they make both the New York Times³ and Fox News.⁴ Do an internet search of "Texas Textbook Wars" to see just how widespread the interest is.

Although the actual revisions will not be posted until mid-April, it appears that recommended changes will include the study of: how Christian principles guided our Founding Fathers, the resurgent conservative movement of the 1980s, the unintended consequences of well-meaning Great Society and other legislation³, and the free market economics of Milton Friedman and Friedrich von Hayek.³ Looks like hip-hop is out. The final vote will be at the May meeting of the SBOE.
