## A Minute with Mary



There is absolutely no doubt that the oil spill in the Gulf of Mexico is catastrophic. It is tragic that the waters and shore lines of the Gulf are being polluted; it is tragic that the animals are suffering and dying; and it is tragic that people's livelihoods are being threatened. It is unquestioned that this accident has very grave consequences to the environment and to the lives of the people of the Gulf. However, what the news media and Washington, DC would like us to forget is that it was **an accident**.

There is no evidence that British Petroleum acted with malice or premeditation. They did not intentionally blow up the well as an act of terrorism or to gain something. Yes, it would seem that they may have acted in an ill-advised manner to speed up the drilling process, but ill-advised does not equate to maliciousness.

Unfortunately, disasters happen all the time. According to the list of the 10 Tragic Accidents in history on the Web site [crunkish.com](http://crunkish.com), there were 14,000 deaths last century related to airplane crashes. Did we suspend air travel? No. Did we set up some rules and regulation regulating air travel? Yes. This same site mentioned the nuclear reactor explosion at Chernobyl. This accident caused the death of 4,000 people and affected the health of millions more. Did we quit using nuclear power? No. Did we revise the rules governing the use of nuclear power? Yes. However, what does our administration do in its infinite wisdom in response to this calamity? Does it step back and look at ways to prevent future blowouts? No, it unconditionally suspends all deep water drilling jeopardizing the livelihoods of millions of workers in the oil and gas industry.

Despite what the media and Washington would have you believe, it seems to me that BP has stepped up and is doing a pretty good job of trying to make things right. They have done a far better job than the government ever could by paying restitution to local businesses and

getting clean-up operations underway, while still working to stop the flow of oil. I'm not sure what poor Anderson Cooper is going to report, but it would now seem that the only people not getting any assistance are the ones who can't pass the drug screening to work for BP or the ones who haven't kept records nor paid taxes on past earnings.

Without a doubt, this is a terrible disaster, and it will take years to make the Gulf and its shore lines like they were. There will be some in the region whose lives will never be the same. But Americans, and especially Southerners, are resilient people. I have no doubt that we will come through this ordeal, inspite of what this administration may or may not do, with the help of each other.

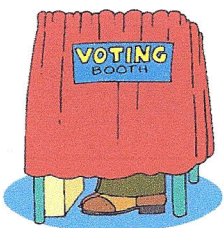

Most recently, Roger served as the Chairman of Texas Victory 2008, the statewide effort to elect Republican candidates.

Roger Williams' civic activities include serving on the Texas Christian University Board of Trustees, his alma mater, and he is a member of the Athletic Hall of Fame. Williams is also a member of the Board of Trustees for the Bush School of Government and Public Service at Texas A&M University. He also serves on the National Football Foundation and College Football Hall of Fame Board of Directors as well as serving on the Admiral Nimitz Foundation Board of Directors in Fredericksburg, Texas and is the Chairman of the USS Fort Worth Steering Committee.

Roger has been a small business owner in Fort Worth and Weatherford, Texas for 38 years after playing professional baseball with the Atlanta Braves organization. He and his wife, Patty, currently reside in Fort Worth and have two daughters.

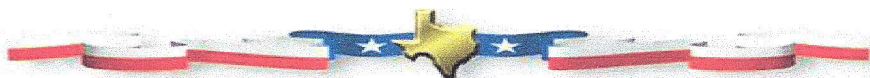

# MINUTES

CY-FAIR REPUBLICAN WOMEN GENERAL MEETING  
July 13, 2010



President, Mary Moss, called the meeting to order at 11:05 a.m. at Carrabba's Italian Grill. Suzanne Davis led us in prayer and pledges to the U.S. and Texas flags. Joy Gregory introduced guests, and Mary Moss welcomed them. Rita Parrish introduced Mr. Jim Murphy who is running for the position of Texas State Representative for District 133. Mr. Murphy formerly held this position in the Texas Legislature from 2007 to 2008. He lost the position in 2008 by one percent of the vote. He discussed issues that will come before the legislature in 2010. The budget is between twelve to eighteen billion dollars short—will need to be cut. Redistricting also will be before the legislature—the Democrats will probably walk out, Texas will gain three to four seats. There will be issues left from the last session which will be taken up in the next session.

## OFFICERS' REPORT:

Secretary, Doris Jones, stated that the June minutes were published in the *CFRW Newsletter*, and asked if there were any corrections to them. The minutes were approved as published in the newsletter.

Treasurer, Barbara Buxton, was not present at the meeting; however, she submitted her report by e-mail. She reported that the balance of our bank account as of May 31, 2010 was \$12,061.39. Deposits of \$2,484.00 and payments of \$1,331.67 were made to the account during the month of June. Our balance as of June 30, 2010, was \$13,213.72. The savings account has a balance of \$1,101.56.

Ways and Means Chair, Millie Alford, stated that she had red t-shirts, denim shirts, cookbooks, the Peter Barnes books, (\$18/each, or \$90 for full set) and strawberry jam for sale. See her if you wish to purchase any of these items.

Newsletter Chair, Betty Guthrie, stated that Monday, July 26, 2010 is the deadline for newsletter articles.

Membership Chair, Joy Gregory, stated that we have 67 voting members, and 88 total members who include Associate Members and Man Associate Members. We are shooting for a total of 81 regular members.

Campaign Activities Chair, Lois Barclay, passed around the Campaign Hours Sheet for members to report their hours spent on Republican activities.

## CAMPAIGN ACTIVITIES - Dawn Shull



The Dodd-Frank financial regulation bill recently passed by Congress contains “pages and pages of massively costly, counterproductive and possibly unconstitutional mandates on nearly every type of business except for those government-sponsored enterprises at the root of the crisis”<sup>1</sup>. Rather than reform Fannie Mae and Freddie Mac who were primarily responsible for the subprime mortgage debacle, the bill will burden many businesses from Wall Street to Main Street including “storefront check cashiers, city governments, small manufacturers, home buyers and credit bureaus.”<sup>2</sup>

Health care reform enacted in Massachusetts in 2006 is a window to how ObamaCare will unfold and it doesn’t portend success. The number of people having access to care has improved somewhat but as of yet there is no measurable improvement in overall health. The number of emergency room visits (with only half constituting true emergencies) remains the same. Unsurprisingly, “health costs continue to soar.”<sup>3</sup> History tells us that entitlements quickly become entrenched so that reducing or eliminating them becomes anathema to elected representatives. So government grows on and on - “unchecked health spending determines government priorities and inflates budget deficits and taxes, with small health gains. And they call this ‘reform’”<sup>3</sup>

Brace yourself for mega tax hikes in 2011. From elapsed tax cuts to “over twenty new or higher taxes in ObamaCare”<sup>4</sup> to higher business taxes, Americans will be giving up more of their income to Uncle Sam. With Congress failing to index the Alternative Minimum Tax, it “will ensnare over 28 million families, up from 4 million last year.”<sup>4</sup> “Studies, statistics, and real life have shown again and again that the businesses and families burdened with the death tax often see themselves forced to cut back on benefits, investments, and employees. The death tax keeps new jobs from being created, hurting not just the affected businesses, but the economy as a whole. Because it is a tax on capital, the death tax destroys as many as 1.5 million jobs that the economy needs as it struggles to recover. Heritage Foundation tax policy expert Curtis Dubay details a replacement for the death tax, and explains why Congress must kill the death tax - now.”<sup>5</sup> Also looming is the VAT (value added tax) which many think Obama’s Deficit Commission will recommend at year’s end.”<sup>7</sup>

We desperately need to elect a Congress that will rein in this runaway tax and spend freight train before we derail. On to November...

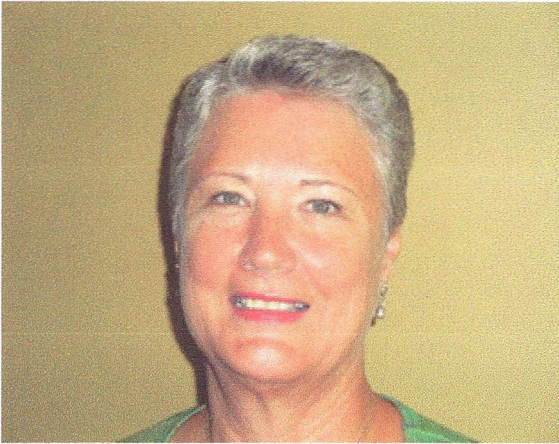

**1<sup>st</sup> VP** – (Program Chairman) Arrange for and introduce the speakers for all regular meetings. Submit an article for newsletter with speaker info; take over for President when President not available; attend board meetings.

**2<sup>nd</sup> VP** – (Ways and Means Chairman) Organize all fund raising activities – Bi-annual major fund raiser (presently High Heels & High Tea), Membership Books ads; CFRW items; keep records in accordance with Treasurer's requirements (sales tax, TEC reporting, etc); take over if President and 1<sup>st</sup> VP not available; attend board meetings.

**3<sup>rd</sup> VP** – (Newsletter Editor) Publish the monthly newsletter; attend board meetings.

**Secretary** – Take the minutes at all regular and board meetings. Submit regular meeting minutes to Newsletter Editor for publication; send notes/cards of thanks, sympathy, congratulations, etc., on behalf of the club as directed by the President; attend board meetings.

**Treasurer** – Keep all financial records in accordance with TEC regulations; give monthly treasurer's reports at regular meetings, make timely submissions of membership; file all reports/forms to TEC, State Comptroller (sales tax, franchise tax report), TFRW, etc.; presents annual budget; attend board meetings.

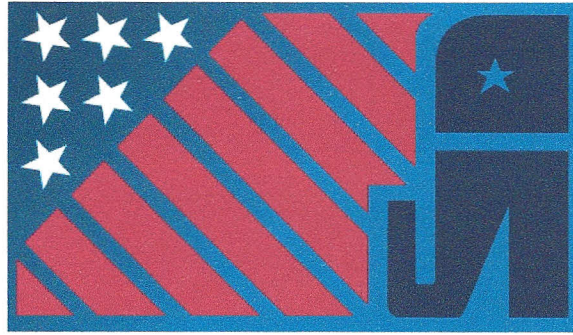
**Caring for America** – Organize club activities related to community service – donations to OI, etc.
