A Minute with Mary



There has been much in the news lately concerning the passage of SB1070 in Arizona. This is the law dealing with illegal immigration. There have been countless articles, op-ed pieces, sound bites, and talking heads expounding on the evils of the bill. (You rarely see the pro point of view in the paper or on the TV).

For the most part the heads would have you believe this law now gives law enforcement the right to stop, arrest, detain and ultimately deport anyone whom they suspect is an illegal alien solely on their appearance. Shame on him for abusing our hospitality; and shame on the ones who stood up and applauded his statements. Whether we agree on everything or not, we are still all Americans first. Do you tolerate anyone speaking poorly about your family? Why would you not only tolerate but also applaud a foreign guest for making disparaging comments about

JOAN NEUHAUS SCHAAN





Speaking at our meeting this month will be Joan Neuhaus Schaan with the subject being terrorism and security in our community and along the Texas borders. Even though the Mexican Border is quite far from Houston, there are many types of crime that happen in the Houston area which start out at the border. Information is a valuable tool and you won't want to miss her presentation. Be sure to make plans to attend this meeting and, of course, bring your friends with you.

Joan Neuhaus Schaan is the fellow in homeland security and terrorism at the Baker Institute which serves the Houston-Harris County region and its population by enhancing regional security. She has served as the executive director of the Houston-Harris County Regional Homeland Security Advisory Council since 2004. This Council is a joint effort of Harris County, the City of Houston and Rice University. She also serves on the board of directors for Crime Stoppers of Houston, Inc.

From 2002 to 2004, Neuhaus Schaan was mobilized to active duty for Operation Noble Eagle/Enduring Freedom and was deployed to Northern Command's 24 Operational Intelligence Watch in Cheyenne Mountain. At the conclusion of her tour, she was awarded the Defense Meritorious Service Medal and authorized to wear the Joint Chiefs of Staff insignia. Prior to mobilization, Neuhaus Schaan served as the project coordinator for the Houston Task Force on Terrorism and led the assessment of Houston's terrorism response mechanisms, a joint effort of the Office of the Mayor of Houston and the Baker Institute. Upon completion, Neuhaus Schaan was chaired as the Thomas Cook and Mary Elizabeth Edwards Fellow for Terrorism at Rice University.

Joan Neuhaus Schaan's first involvement in the field of terrorism and homeland security came as an officer with the United States Naval Reserve, where she became an antiterrorism training officer for her squadron and was responsible for the force protection briefings for deployments to the Americas and Pacific. She was appointed to the Texas Commission on Private Security by Gov. George W. Bush in 1999, and later reappointed by Gov. Rick Perry. Neuhaus Schaan received her B.A. from Williams College and her M.B.A. from the Jesse Jones Graduate School at Rice University. MINUTES

CY-FAIR REPUBLICAN WOMEN GENERAL MEETING May 11, 2010

Joy Gregory welcomed and introduced guests. Since this was our membership drive month and we had many guests. Mary discussed the goals and functions of our club.

LEGISLATIVE - Dawn Shull



Following up the CFRW April Legislative Report, I can report that the Texas State Board of Education has posted and voted on its final recommended social studies curriculum standards.^{1,2} They have been roundly criticized by many on the left but their revisions are, as Robert C. Koons wrote in his recent opinion piece, "small steps in the direction of promoting objectivity in our educational standards." Public Testimony Registrations for May 19, 2010, exceeded 180, the board's final vote was May 21.4

In the coming months our club members can make a difference by helping all Republican candidates running for elections, but particularly those in difficult races. TFRW has a "10 in 2010" vision with the goal of keeping Texas House Republican incumbents in office and electing 10 more. In Harris County Dwayne Bohac⁵, District 138, and Ken Legler⁶, District 144, face tough re-election races. Jim Murphy⁷ is trying to re-take the District 133 seat he barely lost to Democrat Representative Kristi Thibaut in 2008. TFRW identifies five incumbents with challenging re-election races and thirteen Republican candidates that are running against incumbent Democrats. This list will be posted on our CFRW Web site and hard copies will be available at our next meeting.

John Faulk⁸, a candidate for U.S. Congressional District 18, has an uphill battle running against incumbent Sheila Jackson Lee.

To find out where a particular district is, check out the online District Viewer⁹, a map of all Texas Districts - U.S. Congressional, Texas Senate and House, and State Board of Education. To find the more densely populated districts you'll need to zoom in or use the "find" function.
