The U.S. Corporate Tax Rate Becomes the Highest in the World By: Don Carlson

On April 1st, the Japanese Government reduced its corporate tax rate to 39.05% and will further reduce it to 35.64% in 2015. By this action Japan relinquished its status as having the highest corporate tax rate in the industrialized world. Unfortunately for the United States, this action by Japan now means that the United States has inherited the very dubious distinction of having the highest corporate tax rate at 39.2%. These rates are combined rates reflecting not only national taxes but also state, local and (in Japan's case) regional taxes.


Why is this action by Japan important to us? The Government of Japan has been under considerable pressure for many years to invigorate their anemic economy and spur economic growth. They have looked around the world to see what other countries have done in recent years to address similar economic problems and what they have seen is that virtually every industrialized country around the world understands that corporate tax rates have a profound effect as to whether or not a business will succeed or fail.

According to the Organization from Economic Cooperation and Development (OECD), the average 2012 corporate tax rate for the top 34 developed countries in the world is 25.4% Since 2000, 30 of the world's leading economies have cut their corporate tax rates. Germany dropped its top rate by 22 points. Canada cut its by 13 points. Even Russia at 20% and China at 25% have lower rates than the U.S.

Why is our new status another burden for the U.S. economy? Taxes are an integral part of every business decision as to not only pricing but also where to do business and where to locate manufacturing. Bruce Josten, Exec. VP at the U.S. Chamber of Commerce, recently made the following statement: "As countries such as Canada and the United Kingdom have moved to reform their tax systems and lower rates to encourage economic growth, America's inaction puts American worldwide companies at a competitive disadvantage and threatens our economic recovery."

Tax rates are a key part. The U.S. is virtually alone among OECD countries in that it subjects its citizens and its companies to taxation on their worldwide income. Most countries only tax income earned within borders. Thus, a foreign company operating

outside its borders will pay taxes in the country where it earns the money but pays nothing when it brings that money home. A U.S. Corporation must pay all foreign government taxes and then the U.S. Corporate tax on monies earned overseas when they bring it home. As a result, many American companies do not bring their foreign income home where it could be used to support our domestic economy and create jobs. It is currently estimated that U.S. Companies have more than \$2 trillion in overseas profits that they are keeping overseas, rather than pay our corporate tax.

Why should we be concerned about both corporate tax rates and worldwide taxation? The reason is that they are integral to economic recovery and growth. Tax rates as incorporated into pricing that determine whether we win in the competitive international marketplace. Worldwide taxation determines where plants are located and where jobs are created. When a U.S. Corporation makes a decision as to where to build a new \$1 billion factory and that corporation has overseas profits that is not brought home, it can build that \$1 billion plant overseas, compared to building a \$650 million plant if it pays the top corporate tax to bring that money home and build it in the U.S. If you needed to build that \$1 billion facility, where would basic economics tell you to build it?

These are critical decisions that we must face as a nation in the coming months and years. Tax policy and tax rates determine which economy will grow and where jobs will be created. The rest of the industrialized world gets it. If we are to have a vibrant job-producing economy, the United States needs to get it as well!

The Primary Election in Texas, May 29 is almost here (FINALLY). Our mail boxes are getting more and more crowded with candidate flyers and information daily. These flyers come in the form of endorsement candidate lists, generated campaign literature, and sometimes, smear from A word of caution; opponent. before you take any information or endorsement as gospel, do vour OWN homework.

Many of the endorsement lists are a "Pay to Play" deal. That is, in order for a candidate to get on the list, they need to pay the person or organization publishing the list to get their name on the list. So the candidate with the deepest pockets (not necessarily the best choice) gets the endorsement.

And when you receive a negative ad, check to see who paid for the ad and look into them and what their incentive is. You need to determine if what they are saying is indeed the whole truth or a distortion of the truth.

This primary is very important to all of us. We as Republicans need to choose the very best candidates in **ALL** races to face the Democrats come November. So, <u>do your home work</u> – don't rely on someone else to tell you who to vote for. <u>Go to</u>

<u>forums</u>, listen to the candidates speak. <u>Do some research</u>. A good place to start is -

<u>harriscountygop.com</u> – they have a listing of the people on the ballot with links to their official web sites.

Bottom line, be informed and know where this information is coming from.
