She began her judicial service in 1999, when she was appointed to the 309th District Court of Harris County by then Gov. George W. Bush. She was elected to that bench in 2000. In 2001, Governor Rick Perry appointed her to the Court of Appeals for the Fourteenth District of Texas at Houston where she served until October 2009, when she was appointed to the Supreme Court of Texas. She was elected to a full-term in November 2010.

Justice Guzman counts many "firsts" among her professional accomplishments—the first Latina



then elected to a Harris County Family District Court, the first Latina appointed, then elected to

the Houston-based Fourteenth Court of Appeals, and ultimately, the first Latina appointed and elected to the Supreme Court of Texas.

She has been awarded many awards, such as the 2012 Pathfinder Award, by the Texas Women Lawyers; the "2010 Woman of the Year" by LULAC Council 402 and the 2009 Pathfinder Award by the Travis County Women Lawyers Association.

The 2012 Elections are approaching very quickly and our Club needs to take an active role in securing the election for the Romney-Ryan

Ticket. There will be a number of opportunities to participate in the very near future. We will have two more Voter Registration Drives in September and one in October. Sept 15th at the ACE Hardware; Sept. 19th and Oct. 13th at Lone Star College for "CYFest".

We will also need volunteers to help the Daughters of Liberty staff their Campaign headquarters in September and October. There will be phone banks that need volunteers to call voters and neighborhood walks to distribute information. We can attend rallies for candidates and share information with our friends and relatives. I will pass around a list at our next meeting and ask for those willing names of participate in these activities. Check your emails regularly because the pleas for help come out frequently and often with short notice.

With the primary election finally behind us, Victory Chairman and Harris County Judge Ed Emmett wasted no time to arganize our statewide efforts. He met with representatives of most of the state wide office holders as well as the campaign team of the U.S. Senate nominee, Ted Cruz, to review the proposed Victory

calender and fundraising plans.

Judge Emmett noted that because the run off was delayed until July 31st as opposed to when it was originally scheduled in April, most of V i c t o r y 's operations and

fundraising were unavoidably delayed. The judge noted that the regular major Victory contributors did not want to commit their contributions to Victory until after the July 31st run off was concluded. Fortunately, he has already been able to raise some funds, and there are additional funds pledged. Money raised for Victory 2012 will be spent directly on Get Out The Vote (GOTV) to support all of our candidates. GOTV efforts will include phone banks at the Victory

centers, a mail program, as well as recruiting volunteers for targeted races. The judge outlined plans for five Victory centers, dependent upon complete funding, with pending plans to have

Victory centers in Farris County based out of Harris County Republican headquarters, the east Harris County center, Tarrant County center, Bexar County center, and San Patricio center.

The Bexar County Victory Center supporting Congressman Canseco's re-election campaign is up and running. Callers have already made hundreds of phone calls to identify potential supporters of Congressman Canseco. The Texas Solution on Immigration


On June 8 (2012), the Texas Republican Party adopted a state platform that supports a federal guest worker program for aliens to enter the U.S. to work. The proposed program is being called the "Texas Solution", because it addresses the illegal immigration issue from a local prospective (since Obama refuses to propose any real solutions). This Program is important because it avoids mass deportation, and prevents mass amnesty. Furthermore, it is a conservative, market- and law based approach to our nation's immigration quandary.

For the past few years, liberals have used emotions and political pandering as their tools to craft any immigration solution. However, this GOP proposal is put together with logic, common sense, and the rule of law.

The platform has four major points.

- 1.) Secure the U.S. border and the nation.
- 2.) Modernize the federal Social Security Card with anti- counterfeit, technology, but not to be used as a National ID card for U.S. borders and the nation.
- 3.) Begin the "conversation" to clarify Section 1 of the 14th amendment to limit citizenship by birth to those born to a citizen in the United States with no exceptions, and without retroactive removal of citizenship.

4.) Create a temporary worker program to bring skilled and unskilled workers into the United States for temporary periods of time when no U.S. workers are currently available. This program should also require:



- Applicants must pass a full criminal background check;
- Applicants with prior immigration violations would only qualify for the program if they paid the- appropriate fines;
- Applicants and/ or Employers must prove that they can afford and/ or secure private health insurance;
- Applicants must waive any and all rights to apply for financial assistance from any public entitlement programs;
- Applicant must show a proficiency in the English language and complete an American civic class;
- Temporary workers would only be able to work for employers that deduct and match payroll taxes;
- All participants would be issued an individual Temporary-Worker Biometric Identification Card that tracks all address changes and both civil and criminal court appearances as a defendant.

Liberals are always claiming conservatives are "anti-immigrant", but here is a logical and practical approach to the immigration issues and needs of our nation. It avoids mass deportation which would be costly and impractical it prevents



the breakup of families, and it does not create any amnesty programs.

Strict enforcement of immigration law and oversight of the temporary worker program will be important to the success of this program. However, the GOP and conservatives have placed a proposal on the table. It is not a one-sided conservation anymore. Importantly, it will keep many Hispanics from being used as political pawns by liberals and Democrats.

Ted Poe Speaks to Cy Fair Republican Women

As one of the most prolific speakers in the United States

House of Representatives, Congressman Ted Poe was a logical choice as the keynote speaker for the Cy-Fair Republican Women's annual social at the Longwood Golf Pavilion.

Poe used the opportunity to call more than 100 club members and their families to action against the country's ballooning deficit without raising taxes.

"Every day the United States brings in \$5 billion to the federal treasury, but every day the federal government spends \$9 billion," he said.

There are two solutions to fix the deficit: raising taxes or cutting programs, he said.

"47 percent of people in this country pay no income tax. We don't need more taxes; we need more tax payers," he said. "You don't raise taxes during an economic crisis. In our entire history, we've never been able to tax ourselves out of an economic crisis."

Currently, President Obama is threatening to let the Bush tax cuts expire for the wealthy. Poe believes the move would further damage the economy, explaining that low tax

rates promote business expansion and a broader tax base.

"Because the federal government has tied up capital, small businesses aren't wanting to spend any money. If they have any, they hang on to it," he said. "Lowering the tax rate actually brings in more revenue for the government."

Instead of a system were a few support the many, Poe wants to move to a fair tax system, which would allow the government to get rid of the IRS, he said. His view directly contrasts with the current administration, which recently hired 1600 new IRS agents to coincide with the expansion of the Affordable Care Act.

"There are 90 of us in favor of a fair tax bill," he said. "But it's not going anywhere until the public supports it."

Poe, who serves on the foreign affairs committee, also wants to change the way foreign aid is distributed. The problem is committee members have to vote on which countries receive foreign aid in bulk instead of individually, he said. Out of 192 countries, 158 of them are lumped together on a list, he said. His most recent triumph was authoring a bill that would cut off approximately \$650 million of aid to Pakistan, a mere percentage of the full \$1.3 billion the United States sent to the country.

"We don't need to pay them to betray us. They'll do it for free," he said.

He also advocated letting the death tax die because "it makes no sense," developing the Keystone Pipeline to become more energy independent and reigning in out-of-control spending.

Poe ended by urging everyone to show their support in the November election.

"Elections are campaigns," he said.
"It is a military concept and the battle is over in November. but it takes place from now until election day, and you have to be engaged in the battle."
