# LEGISLATIVE

While we are all still recovering from the disappointment of a very difficult loss of the Presidential campaign, we do have important legislative activity to start watching here at home. As many of you know, our state Legislature meets in regular session beginning the second Tuesday in January of odd-numbered years for 140 calendar days. Though the actual session has not yet begun, our legislators have

already been very busy working in committees and preparing legislation. Thousands of bills get filed during every regular session. Special sessions can only be called by the Governor for 30 days and lawmakers may consider only those issues designated by the Governor. There is a strong likelihood that there will be a special session in this two year term.



Texas House Speaker Joe Straus has emphasized that he will be focusing attention on the important issues of transportation education, water, and transparency. The state has serious issues to address to support the rapidly growing population - from 20 million in 2000 to 33 million by 2030. Education resources and infrastructure are the things that will help support jobs and continued economic growth. The Speaker continues to work toward making our state budget more transparent and accountable to taxpayers. The state has allowed money to sit in General Revenue Dedicated funds to certify the rest of the budget. Speaker Strauss has appointed a committee to develop recommendations for truth in taxation and fiscally responsible appropriations. Our Representative Patricia Harless was appointed to serve on the committee.

Water plays a vital role in our economy. In 2005, CyFair RW's first year, Comptroller Susan Combs, then Texas Agriculture Commissioner, spoke to our club and told us to watch how big of an issue water would become in the coming years and it will now be a focus in this coming session. As Speaker Strauss pointed out, "I don't want to reach a day where a Texas company announces it's moving to Florida or Ohio because of water issues". 2011's drought and brutal heat brought

has focus the importance of conservation efforts which must be balanced with cattle raiser's property rights.

One issue that may not be a part of this legislative session is school funding, and that is why there may be a special session coming up after this regular session. There has been much debate about school funding formulas. There are currently lawsuits charging that the current system is unfair. The court will probably rule in January or February but the case will probably not be ultimately decided until it reaches the Texas Supreme Court. Therefore, the legislature will probably

not address the issue until they get the guidelines from the courts which is not likely to happen during this regular session.

As you watch the legislative debates, you will see that many of the divisions on the issues are not between Republicans and Democrats, but, rather between rural, urban, and suburban perspectives. For an opportunity to watch the process more

closely, be sure to mark your calendars for April 18 when we will travel to Austin for TFRW's Legislative Day. It will be a great time to possibly sit in on a committee hearing, visit your legislator's office, and hear from our Texas elected officials - where, fortunately, Republicans still hold all statewide offices.

### A Note from Patricia Harless

Happy New Year. I hope you all had a wonderful holiday season. Next Tuesday, January 8th, marks the Opening Day of the 83rd Texas Legislature. I am honored to represent the citizens of House District 126 during what will surely be a landmark session.

#### **Swearing-In Information**

On Opening Day, swearing-in ceremonies will be held in both the House of Representatives and Senate Chambers. On Tuesday morning please join us for breakfast in my Capitol office - E2.408. The swearing-in ceremony starts at 12:00 noon. Our office will be open at 8:00 a.m. and we will be serving light breakfast refreshments. At 10:30 a.m. we will meet on the North steps of the Capitol for a group picture and then you may either go to the House Gallery or back to our office to watch the swearing-in proceedings. We will have multiple televisions on in our office, but should you decide to watch from the Gallery, please get here early to get in line as seating is on a first-come, first-serve basis.

#### **Searching for Legislative Information**

In an effort to make the legislative process more open and accessible to the public, the House and Senate have created programs that allow citizens to track legislation, monitor committee hearings and watch either chamber as they meet in daily session on the House and Senate Floors. All of this can be found by visiting the website set up for the legislature: <a href="https://www.capitol.state.tx.us">www.capitol.state.tx.us</a>. If you are looking for a particular piece of legislation, you can search for it based on the bill number or, if you don't have that, a key word or phrase. The "Additional Searches" section of website provides links to a variety of areas that can be affected by legislation. Some of those include Amendments to bills, Texas Statutes, the Constitution and Administrative Code. This section also allows a person to look at any Record Vote taken in either the House or the Senate. The "My TLO" section of the website provides citizens with a variety of resources that enable them to follow legislation and legislative activities. With an email address and password you can create custom Bill Tracking Lists and receive email alerts when there is any type of action taken on the bills on that list, view information on a PDA or cell phone, and save bill and text searches to be viewed later.

#### **Daily Legislative Sessions and Committee Hearings**

To watch the House or Senate in session, or to view a Committee hearing, simply choose the Chamber you are interested in by clicking the "Video Broadcasts" link in the *Legislative Activity* section located on the right hand side of the Homepage. Broadcasts are in real-time and provide citizens with the opportunity to follow legislation that is being debated even if they are unable to be there in person.

#### **Honorary Pages**

The House Honorary Page Program is a great opportunity for students 8 to 18 years of age to experience the Capitol and the legislature. Pages assist our House Sergeants with their duties, which include spending time on the House Floor while the legislature is in daily session. A page is allowed to serve 1 half-day shift, either in the morning or afternoon, which makes this an easy day trip to Austin. Each session every member is allowed a total of 10 pages. All requests are on a first-come, first serve basis and slots fill up quickly, with the week of Spring Break filling up first. If you know a student in District 126 that would be interested in serving, please have them contact our office as soon as possible.
