



#### **LEGISLATIVE** ~ Jan Ott

#### The 83rd Texas Legislature Regular Session

Of course, this is an important time to be watching what is going on in our State Legislature. I can only touch on a few things that might be of interest, and by the time you read this article it may be out of date! Please go to the web site listed at the end of the article for the latest information. Rainy Day Fund - This Fund is the State's savings account intended for unexpected budget shortfalls and requires a two-thirds majority vote of the legislature to use it. The Texas Senate has just approved a proposed constitutional amendment to ask voters to approve tapping the fund for water projects, highways and public schools. We will have to see how the House handles this amendment as it appears that they may not completely agree. If they do, however, it will be on the ballot in November. Senator Tommy Williams, who proposed the amendment, says it would save the state billions of dollars of debt service by using the fund, rather than issuing bonds that are currently planned for roads. Although only a small portion of the tapped money would go to schools (school funding will already be increased due to a large increase in property values), that portion of the rainy day fund would be used to resurrect teacher merit pay and to increase the basic state allotment to schools. In the House, Speaker Strauss wants to focus a portion of the fund for much needed water projects.

Campaign Money Transparency - The House has now unanimously passed a bill out of committee that would require nonprofit groups that are primarily involved in social welfare work, 501(c)(4) organizations, but engage in political activity to disclose their donors. The bill, Senate Bill 346, already passed in the Senate so if it passes the full House unchanged it would go straight to Governor Perry. Texas does not have public financing of campaigns or contribution limits, so the only thing we can rely upon is disclosure. The bill would require disclosure of donors who give more than \$1,000 to a group that engages in more than \$25,000 of political activity intended to influence an election. The bill would close a loophole that allows campaigns to be infused with secret money. There is an interesting back story to this bill. The bill passed the Senate by a wide margin, but the next day they tried to recall it. It had already been sent to the House so it could not be brought back. If there are any amendments in the House, it would return to the Senate where it now would probably not pass.

Education - The Texas Senate is set to discuss the overhaul of school curriculum and standardized testing. The House

has approved legislation, HB5, aimed at allowing more vocational based training and to reduce the number of standardized tests required for high school graduation. The bill passed the House by a 145-2 vote and has received broad support from parents, educators and business leaders. The most debated part of the bill was the restructuring of high school diploma requirements which require four years of math, science, social studies and English. The bill still requires 16 hours in core credit courses, but gives more flexibility to choose areas of focus. Proponents say they are not backing away from rigor or accountability.



### LEGISLATIVE UPDATE Patricia Harless



Dear Friends,

The House and Senate have both passed their versions of the Appropriations bill, and are now in conference to work out the differences.

After many hours of debate, the House passed the CSHB 1 by a vote of 135 Ayes and 12 Nays. Texas' economic climate has vastly improved since last session and we were able to restore some of the drastic cuts we were forced to make in 2011. The measure, authored by House Appropriations Committee Chair Jim Pitts (R – Waxahachie), appropriates \$193.8 billion over two years, funded within available revenue and under the Constitutional spending limit. It increases funding for Public Education, Higher Education and Health and Human Services, including:

- \$2.7 billion increase in funding for public education (an 8.6 percent increase)
- Increase in the State's contribution rate for retired teachers' pensions
- \$175 million increase for financial aid programs, including \$150 million increase for Texas Grants, a program that provides financial assistance to our highest performing students in need.
- \$265 million increase for mental health programs.
- \$170 million increase for Child Protective Services to reduce delinquent investigations and lower caseloads.
- Fully funding projected caseloads for Medicaid, CHIP and foster care programs.

During the budget debate, some so-called "watchdog" groups began emailing and robo-calling regarding how members were choosing to send money to Hollywood, through the Moving Images Industry Incentive Program (MIIIP), over giving it to retired teachers. As with most propaganda of this kind, it failed to give the full picture. Some of the facts they did not include:

While there were provisions impacting the MIIIP, of major concern to the members of the House was the fact that the amendment would have gutted the budget of the Historical Commission, removing approximately \$14.1 million and taking it back to 2012-2013 funding levels. These significant cuts would severely limit the Historical Commission's ability to carry out their mission which is to preserve the State's historic landmarks and artifacts, which include: \*Courthouse Preservation. \*Maintenance and operation of historic sites. \*Management of the State Historical Markers Program which provides historic markers to commemorate diverse topics, including: the history and architecture of houses, commercial and public buildings, religious congregations, and military sites; events that changed the course of local and state history; and individuals who have made lasting contributions to our state, community organizations, and businesses. \*Archeological heritage protection through the administration of the State Archeological Landmark designation program (SAL). Serving as support staff for the Texas Antiquities Advisory Board, which evaluates sites for SAL designation and issues state antiquities permits; recording and evaluating archeological sites; advising archeologists, property owners, and other individuals concerning the laws and rules that apply when unmarked cemeteries are discovered; and conducting and reporting on archeological research and investigations.

Since the inception of the MIIIP program in September 2009, through May 2013, the state has awarded \$61,738,491 in grants to the MIIIP, and have seen a return of \$481,761,856 – a Return on Investment (ROI) of an astonishing 800%; The program is not a "Hollywood" program – the film industry is just one-fourth of the industries eligible for the MIIIP (Moving Images Industry Incentive Program). The complete list of eligible industries include film, television, TV commercials, and video games; The monies appropriated for film production are paid only after the company provides eligible receipts for reimbursement; Only reimbursable expenses are paid, which include the hiring of Texas citizens and Texas vendors, ensuring a positive return on investment. The amendment offered was one of several amendments which were "sold" as helping TRS-Care, but: None of the amendments were approved by the Texas Retired Teachers Association (TRTA), who was not even asked if they wanted these amendments offered. This stunt threatened to kill the two amendments the TRTA actually wanted and had filed on their behalf -- both of which I voted for.
