It will come as no surprise to each of you that 2014 is an important year as the mid-term elections will occur in November. Equally important is the Texas Primary Election which is scheduled for March of 2014. Each of us will have many opportunities to serve this year, but none are as important as staffing the polling places. I would like to share an article written by our own Barbara Buxton. The article explains what is involved in serving our county as a poll worker. Please consider volunteering in the election process. Thank you, Barbara, for sharing with us.

As members of Republican Women's Clubs, we are committed to helping get Republican candidates elected. •There are many women who are also involved in the actual election process...for example, working at the polls on Election Day.

Each precinct in a county has a Presiding Election Judge, an Alternate Judge and several clerks depending on the size of the precinct. •Although there are some precincts that have numerous people willing to help, there are many that have very few. •Finding these workers really falls to the Presiding Election Judge. •The county does give out a list of possible workers but my experience has been that they have either moved or

passed on. •Luckily, workers do not have to live in the precinct where they work but they must live in the same county and, of course, be registered to vote. •Since 2008, I have called on the wonderful women of CFRW to help out at my polling location several times and they have always come through.

Having enough workers for each precinct allows for accessibility to the home area and helps prevent long lines that can occur when precincts have to be combined.

•Being able to vote near their homes also tends to increase voter turnout. You should know that you are offering a very important and vital service in the election process when you work on Election Day. Before I started working at the polls, I didn't know how simple it would be to do such an important job. •Basically, you fill out an online application on the County Clerk's website or let a Presiding Election Judge know that you want to help. •About a month before the election, there will be a paid three hour training to acquaint you with the voting machine and some basic facts. •You will learn how to set up the voting booth and practice using the JBC machine (Judge's Booth Controller). •Usually, there are many classes throughout the month so you can sign up for the one most convenient for you. Sometimes, there will be workers who have not gone to the training but with a little tutoring from the presiding election judge, they can verify voters or be greeters.

If you speak Spanish, Vietnamese or Chinese, you are very much needed because it is a requirement to have workers that speak one or more of these languages depending on the make-

up of the precinct.

Each worker is paid for the hours worked. •You work at the polling place from about 6 a.m. to 8 p.m. •The polls are open from 7 a.m. to 7 p.m.

I would like to see each club take on the project of creating and maintaining an updated database of their members who would be willing to work on Election Day and then providing this list to the County Clerk or the Presiding Election Judges in their area before an election. •The Republican Women's clubs are the perfect place to find engaged, active members who are willing to help or who know someone who is looking for some way to help that doesn't require a long term commitment.

Even if there isn't a database, you can still let the County Clerk, Presiding Election Judge or Precinct Chair know that you are willing to help. •The Republican Primary in March 2014 will require many helpers because only Republicans will work in the polls for their primary election. Serving your community in the electoral process is most rewarding and of all the different hats that I wear, this is one of my favorites. ~ Barbara Buxton

Taking a Closer Look at the Budget Deal

The budget deal negotiated by Congressman Paul Ryan and Senator Patty Murray has been both praised and slammed by Republicans. It is not surprising that Republicans disagree on the budget deal as they have become very adept at circling the wagons for the circular firing squad. The budget that the House passed back in March is the budget most Republicans want, but, it had no chance of passing the Senate or of being signed by President Obama. To be very clear, no one thinks this budget is an enormous accomplishment, but, it is a small step so that we do not face another government shutdown that would hurt Republicans in an election year. We must win the Senate and the White House to truly fix our fiscal problems.

There are definite positives in the budget deal. Over the life of the deal it keeps 92% of the sequester spending cuts and it keeps 70% of the cuts over the next two years while, additionally, it enacts permanent cuts that include federal workers contributing more to their own pensions. There are NO tax increases. Without this deal, the military would have borne the full force of the sequestration spending cuts starting in January. The Ryan-Murray deal relieves \$31.5 billion in sequestration cuts to defense over the next two years. Where this helps the most is in military readiness, which right now is very concerning. Defense Secretary Chuck Hagel said in a November speech that because of budget cuts, only 2 of the Army's 43 brigade active-duty combat teams are ready for combat, and Marine Corps units that are not going to Afghanistan are getting 30 percent less funding. At one point this summer, only 8 warplanes were ready to respond to an emergency away from front-lines operations.

Some of the criticisms of the bill have focused on the annual cost-of-living adjustment (COLA) by one percentage point for military retirees under the age of 62. The bill, according to Paul Ryan, gives them a slightly smaller adjustment for inflation because they're still in their working years and in most cases earning another paycheck. This cut does not take effect until 2016, giving Congress time to come up with an alternative way to make up the cut, and saves \$6 billion in the

defense budget over the next 10 years. The savings stay with the Department of Defense where it can go to things such as readiness, the troops, to brigades or to buying equipment. There is also a "catch-up provision" so that at age 62 the retiree's pension goes up to where it would have been without the COLA reduction.

Should we be satisfied with this deal? Would we be better off with nothing? Was it better than all of the realistic alternatives? There are many outside groups that have been very vocal against the deal. Their arguments against it is a huge fundraising opportunity for them as long as they are very vocal with their opposition and it is used to "primary" Republicans that are up for reelection. Would we be better off using our energy and resources to defeat Democrats and gain back the Senate in 2014 and the White House in 2016?


