Donna Bahorich is the District 6 State Board of Education member and brings to her job experience in business, education and politics.

Donna was elected to the state board in Nov. 2012 and took office on Jan. 1, 2013. She serves on the Committee on School Initiatives, which oversees agenda items related to charter schools, State Board for Educator Certification rules, and the appointment of school board members for those districts located on military bases. Bahorich previously chaired this committee. She also is a member of the board's Ad Hoc Committee on the Long-Range Plan for Public Education.

After graduating from Virginia Tech University with a Bachelor of Science degree in financial management, Bahorich went to work in the telecommunications industry. She was first employed by the Chesapeake & Potomac Telephone Company, under the AT&T umbrella, and later transferred to Mountain Bell. She also served as a loaned executive to the United Way in her community.

In 1990, Bahorich earned a Master of Arts degree in counseling from Liberty University.

An active community volunteer, Bahorich served as a member of the West Houston P-16 Council; graduated from the Leadership Houston program, served as president of the Daughters of Liberty Republican Women; and is a member of the pastor's council at Houston Vineyard Church.

What about HB 2608?

House Bill 2608 was filed by State Representative Jim Murphy of Houston. The bill is designed to eliminate the Legislature's review of retirement benefits and approving changes that cities and pensions make for the local police, firefighters and municipal employees.

In a recent press release Jim Murphy stated, "The bill's concept is simple. It is about local control of expenses and taxes," said Murphy. "Why should state legislators tell local communities what to pay their employees or what to pay in taxes?"

HB 2608 wouldn't change pensions or benefits already earned. "The pensions of those already retired are fully protected as well as the benefits earned by those still working," added Murphy. "We value the service of these men and women and are committed to securing their retirement benefits." According to Jim Murphy's press release, "Most local pensions in Texas are locally controlled. HB 2608 would eliminate the special treatment some plans have been given while still mandating State oversight through the Pension Review Board. The Pension Review Board's role is to ensure actuarial integrity in local pension funds."

Representative Murphy says that he sees a "groundswell of support from across our state and this will grow as people become aware of the benefits of HB 2608. We appreciate this help in correcting a fundamental policy flaw that is a growing threat to both taxpayers and their valued employees."

There is opposition to HB 2608 which The Star Telegram addressed in an article on 04-17-2015 by Max Patterson. He considers the bill to be a "potentially damaging measure". He also says that members of the Texas Association of Public Employees Retirement Systems oppose the bill because they feel it would alter the structure of pensions in cities around the state. In Mr. Patterson's report, he says HB 2608 is "attempting to persuade a majority of legislators that the problems being experienced in Houston warrant wholesale change to the structure of pensions across Texas." He further states that the Star Telegram's view is that 'Houston's problems with its pensions didn't stem from involving the Legislature. Decades ago, various leaders began short-changing the pensions of the money they needed to remain actuarially viable."

Patterson reports that TEXPER, which publishes a quarterly magazine about pension issues across the state and nation, "keeps an eye on the investment of local pensions. Our yearly research shows most pensions, when given a chance by their cities, do a great job of earning the investment returns needed to keep the promises their city makes to public employees."

Another report by Kimberly Reeves, Capitol reporter-Austin Business Journal, in an April 21, 2015 article says that "even members of the campaign to pass Murphy's legislation – which has a companion from Sen. Paul Bettencourt, R-Houston – did not know three weeks ago that Houston voters opted out of constitutional state provision to protect local pensions in 2003."

Ms. Reeves also went on to say "What makes this topic especially touchy is Houston police officers also face a challenge most teachers in Texas already know. They are opted out of the Social Security system. That means the only retirement income police officers and firefighters in Houston will know is a pension." Additionally, she reported that Ray Hunt of the Houston Police Officers Union said "I know that this has been laid out for all of Texas, but this is something about Houston. This is about putting a squeeze on the Houston Fire Department."

According to Ms. Reeves, Representative Murphy is promising that the concerns the Houston Police Officers Union raised are addressed. In his testimony to the house, Murphy emphasized that Houston retirement systems will be protected as actuarially sound and properly managed by the state because of his committee's substitute of House Bill 2608.

Strong support for HB 2608 was expressed by the R Street Institute in Austin on April 20, 2015. Josiah Neeley, R Street's Texas director of this Washington based think tank, said "Local governments need to have control over their pension systems if they are to govern effectively. This bill will restore local control over public retirement systems and end the growing practice of making plans difficult to change by enshrining them in state law. It's important for stakeholders in the community to have a seat at the table when it comes to their own employee retirement plans," said Neeley.

Rally Against Human Trafficking April 16, 2015 Micheline Hutson

As part of 2015 Texas Federation of Republican Women Legislative Day, Cy-Fair Republican Women were invited to rally on the south steps of the Capitol. CFRW members Micheline Hutson and Lori Bartley attended at 9:00 a.m. in support of **HB 10: Relating to certain criminal and civil consequences of trafficking of persons, compelling prostitution, and certain other related criminal offenses; to the prevention, prosecution, and punishment of those offenses, and to compensation paid to victims of those offenses.**

This bill was passed by the Texas House of Representatives on March 25, 2015 and referred to the Senate Committee on Criminal Justice, chaired by Senators John Whitmire and Joan Huffman. At this writing, no action has been taken by this committee.

Attendees listened to presentations by law enforcement, victims' advocates and sponsors of HB 10. The National Federation of Republican Women is focused on anti-human trafficking legislation in the states and at the federal level. The Republican Party was founded to combat slavery in 1856. Human Trafficking is modern slavery. This is not a "third-world problem". This is not just a "prostitution" problem. It is an "FM 1960 problem".
