I hope everyone saw the debate and is thinking about your choice for our nominee. As most of you know, I've been in Phoenix, AZ for the past week, and believe me, I've heard a LOT of opinions.

The National Federation of Republican Women Convention was held in Phoenix, AZ last week. Jan Ott, Rita Parrish, and I attended, along with my sister, Linda Bomar who attended as a Guest. We were all impressed with the women who attended from all over the United Sates. We enjoyed all the amenities of the beautiful J.W. Marriott Resort and visited with many of the nearly 1400 women who attended. Did everything run smooth as silk? *No...* Were the lines long and did we have to walk miles and miles each day til our feet hurt? *Ye.s..* Did the overall experience grow us as individuals and Republican Women? *YES*! Did we come home ready to work for our party? *YES*!

From the moment we checked in until the last meeting on Sunday afternoon, the convention was filled with so much information, my brain was hurting. We met wonderful, hard-working, friendly women who love their country, love their clubs, and strive to make their organizations the best they can be. I feel like I've made some new friends for life.

AWARDS! We got awards! There were almost 500 awards received. Twenty-three states, including Texas received the highly coveted **Betty Heitman Award**. Campaign awards for most volunteer hours went to California, Texas, Tennessee, Arizona, New Mexico, and California.

NFRW members reported 4.3 million campaign hours. The Yellow Rose of Texas Republican Women received a Caring for America award, and Ronda Lacy and the Lake Conroe Republican Women reported over 6,000 hours. Our Texas President, Jody Rushton won National Member-at-Large. CFRW received the Diamond Award! Carly Fiorina won the straw poll for Presidential Nominee! She deserved it! Her presentation to the convention was full of positive words of hope and encouragement. Her background in sales and her ability to communicate and articulate her message is awesome. She is tough and introduced herself with the comment, "Ladies, look at this face." She had 27% of the Straw Poll with 871 votes cast by registered attendees of the convention. Ted Cruz followed with 20%. Ben Carson had 17% and Donald Trump had 14%. Janet Huckabee represented her husband in a great speech about his accomplishments and the ability to "take on" the Clintons. Congresswoman Kay Granger spoke for Florida Governor Jeb Bush; Representative Mary Ann Janusa from Iowa, asked us to take a closer look and listen to John Kasich. Other notables were Arizona First Lady Angela Ducey, Arizona Governor Doug Ducey, Michele Reagan, Arizona Secretary of State, and RNC Co-Chair, Sharon Day. There were video comments from Donald Trump and Ben Carson. Our Texas President, Jody Rushton won National Member-at-Large. What a memorable

Kellyanne Conway presented the polling results and
gave an outstanding presentation commending
Republican Women for their contribution of time and
talent. The convention ended with a beautiful Prayer
Breakfast on Sunday morning. We heard some

and our hearts were touched as the names of our
members who passed this last year were read.
I do hope that everyone who can will attend the
Texas state convention in Lubbock in November.

Legislative - by Rita Parrish

Congressman Michael McCaul, who is the Chairman of the House Committee on Homeland Security, visited with Cy-Fair Republican Women on August 18th and spoke with us on many of the issues he has been involved in over the past months. Border security was, of course, high on his list of priorities as was all potential terrorist threats. He has since then become concerned with the Syrian Refugee situation in Europe and has issued a couple of statements because it has now become even more relevant to the U.S.

In a September 9th interview on *Fox and Friends*, Steve Doocy mentioned that several months prior Isis threatened to send ½ million migrants to Europe as a psychological weapon - meaning there could be bad guys and good guys sent in together. Steve said, "You wrote a letter to the President regarding this. What did you say?" Congressman McCaul said, "I'm concerned about the safety not only of the Europeans but of the American people first and foremost. The FBI has told me, because of the lack of human intelligence, we can't properly vet these individuals past any databases. And until I have that assurance, I can't support a policy that would provide a jihadist pipeline into the United States. We have read their documents themselves where they talk about exploiting the refugee issue to get into the United States. Look, we are very compassionate on this issue. I think it's a tragedy of extraordinary proportions. But we've got to do this thing right, a wholesale let-in of thousands of Syrians into the United States, not knowing who they are, I think would be very irresponsible." One month later to the day, perhaps the following bill will help with these concerns.

Press Release, For Immediate Release, September 18, 2015

Today, Congressman McCaul, Chairman of the House Committee on Homeland Security, introduced the <u>Refugee Resettlement Oversight and Security Act.</u> If enacted into law, this legislation would give the American people's representatives the chance to vote up or down on the President's plan to resettle 10,000 Syrian refugees into the United States and improve the security vetting process. Specifically, this bill will:

- Require affirmative approval by both the House and Senate before any refugees are admitted to the U.S.
- Allow Congress to block any inadequate refugee resettlement plan put forward by the President.
- Require the Administration, when considering the admission of refugees from Iraq and Syria, to prioritize the resettlement of oppressed religious minorities.
- Ensure DHS, in coordination with DNI and FBI, provides new security assurances before admitting refugees into the country and for the Governmental Accountability Office to conduct a sweeping review of security gaps in the current refugee screening process.

McCaul: "Many Americans are understandably concerned about the threat posed by inadequate security screening procedures for refugee seeking entry into the United States. ISIS themselves have stated their intention to take advantage of the crisis to infiltrate the west. We have to take this threat seriously.

This bill will rein in the Administration's refugee resettlement plans and give Congress more control over the process by requiring the Administration to get affirmative approval from Congress through the enactment of a joint resolution before any refugees may be admitted into the United States.

These important security updates to the refugee process are necessary for not only the security of the United States, but for the safety of the refugees."


