Melissa Rotholz Associate Director of Shield Bearer Working to Help Heal the Hearts of Trafficked Victims

In the last five years Shield Bearer has helped to heal the hearts of hundreds of sex trafficked victims. About 25% were internationally trafficked women while the others were domestically trafficked,

some as early as twelve years old. They have coordinated training of the HEART model for trauma recovery with leading Christian researchers from Regents in an effort to find evidenced based approaches to treatment.

Melissa Rotholz leads teams at Shield Bearer that provides professional counseling services and programs for survivors of trauma (including crime, abuse, human trafficking, natural disasters, domestic violence, and war), struggling marriages and families, and many other hurting hearts. She has over fifteen years of experience leading teams dedicated to elevating individual and organization performance through training, programs, engagement, and marketing.

Melissa is passionate about supporting and advancing both the professional and personal lives of women in the community. She currently serves as President of Women Empowering Women Express Network (WEWEN) of the American Business Women's Association, as a Mentor for the Cy-Fair Express Network (CYFEN), on the Senior Recognition Committee for the Cypress Gems Chapter of the National Charity League, on the Gala Committee of the Houston Northwest Chamber of Commerce, and as an Ambassador for the Greater Tomball Area Chamber of Commerce. She has created a Mentor Program for homeless women and community volunteers and a Mother Daughter Program for teens that focuses on building strength physically, emotionally, mentally, and spiritually. Melissa was named 2017 ABWA-WEWEN Woman of the Year and 2018 Federation of Houston Professional Women (FHPW) Woman of Excellence.

CFRW Bail Reform Call to Action

In our September newsletter, we reported on Governor Abbott's August 7, 2018 announcement requesting that the Texas Legislature enact legislation based upon his proposals for bail reform. The Governor has titled the initiative "The Damon Allen Act" in honor of the Texas law enforcement officer who lost his life to a suspect with prior convictions and additional pending charges but who was released on minimal bail as a result of the court not being aware of the defendant's history.

To clarify, no <u>bill</u> has yet been drafted for introduction to the Texas Legislature scheduled to convene in January. However, it is not unusual for the drafting to be done well in advance of the Legislative Session. As of date of this article, and after having checked with the Governor's Office, we know of no action having yet been taken to write the proposed legislation.

The need and opportunity presented by Governor Abbott's proposal found support at the October meeting of CFRW's Executive Board where the Board voted to recommend that the CFRW membership endorse Governor Abbott's bail reform initiative and request that our State Representatives prepare and adopt legislation incorporating the proposals found in The Damon Allen Act as presented by the Governor.

This is a chance for our CFRW membership to be involved at the ground floor with the creation and passage of legislation. We are asking our members to write to their individual Texas State Representatives asking them to prepare and support such a bill. To make this as convenient as possible, postcards and proposed text will be available at CFRW's November membership meeting so you can write your State Representative during the meeting. The postcards will be collected up and mailed following the meeting. Of course, you can supplement by writing further and engage with multiple members of the Texas House, but we look forward to making a strong, initial effort at our meeting on November 13.

From there, we will monitor the efforts of our Legislators concerning the matter, and if written and introduced as a bill, we will follow its progress throughout the Legislative Session.

Thank you for your consideration. We look forward to working together as a club on this legislative action program in November and forward.
